BIRD FEEDERS

The Board of Directors reminds all Owners and residents at Woodside Trails that bird feeders are discouraged as they attract rodents and pests from the surrounding wooded areas, such as squirrels and raccoons, which can nest in the attics of our buildings causing damage and requiring costly exterminators and repairs. Please do not feed any wildlife, including birds.

Woodside Trails communicates with Owners and residents in various ways, one of which being email. Email provides a free and easy way of communicating that is faster than regular mail and, for all community communications, takes less time than calling everyone on the phone. UTILITY SHUT-OFF VALVES

In the event of an emergency, it is vital you know where your water and gas shutoff valves are located within your home, so as to act quickly and minimize damage. You should also take notice of where your electrical breakers are located. If you live in a building with a common area where shutoffs are located that control the entire building, familiarize yourself with this so as to be able to act if ever it is necessary. RECYCLE AND BULK GARBAGE REMINDERS

Woodside Trails provides recycling dumpsters, for the use of all Owners and residents in the community, located in the parking lot of the Clubhouse. Out of respect for your neighbors, please ensure you break down any boxes you deposit into these dumpsters, and only deposit recyclables into these dumpsters. Never should these dumpsters be used for non-recyclable or bulk items.

The Board reminds everyone that on the last garbage collection day of each month, Republic Services will accept bulk items for no additional charge. Please utilize this service and do not discard bulk items in the recycle dumpsters or elsewhere on the property.

SPEEDING - PLEASE SLOW DOWN!

As we have a fair number of families living in our community, and with school aged children playing outdoors in the beautiful spring weather, we remind everyone to be aware of their surroundings at all times when navigating the streets within the community, and to please do so at a reasonable speed (20 MPH or less). Our streets have several blind curves and more than once a jogger, dog walker, or child-at-play has nearly been struck by a vehicle coming around a bend. Please take it slow, for the safety of everyone!

VEHILCE/PARKING POLICY

The Board of Directors would like to remind everyone of the vehicle and parking policy at Woodside Trails. All vehicles parked in our community must display proper and valid license! Unlicensed and improperly licensed vehicles will be towed from the community, this includes the upper parking lot near the clubhouse. Vehicles must also be in good condition and able to operate under their own power. If you have a project car, please keep it parked in your garage with the door closed. Any vehicle parked on the street where and "no parking" sign is present will be towed from the community, no exceptions. Vehicles parked in these areas make navigating the streets difficult and potentially dangerous for other drivers! Please keep these rules in mind when parking and driving in the community! REMINDER: CLUBHOUSE RENTAL

Cost of renting the clubhouse is \$75.00, a \$250.00 refundable security deposit is kept in case of damage to the property. FIREPLACE MAINTENANCE

Per Woodside Trails policy, all fireplace chimneys within the community need to be kept clean on a regular basis. It is the responsibility of the Owners to ensure their chimney is kept in good condition. Improperly maintained chimneys create a potential fire hazard and therefore endanger the lives and property of both the Owner of that chimney and others residing in the building. Please take proper action to ensure your compliance with this policy, in the interest of safety! Thank you for your help in keeping WST a safe place to live.

SNOW REMOVAL POLICY REMINDER

Owners and residents of Woodside Trails are reminded that snow removal services only occur when more than two inches of accumulation is present on the driveways and sidewalks within the community. Please be very careful and never expect a surface to be treated with ice melt when walking outside in inclement weather. Please consider limiting your travel in icy and snowy conditions to reduce risk of injury sustained from a fall or a vehicle accident.

DECK STAINING PROJECT UPDATE

As you may know, the third phase of deck staining in the community has commenced. The second phase is due to be completed within the next couple of weeks, weather permitting. The Board of Directors is pleased to announce it was so pleased with the quality of work done on phase two, it has selected to continue with the services of Neubauer Painting for phase three. Phase two included all buildings on Pine Ridge Trails and phase three will include all remaining apartment style and "stacked" style buildings and will be completed in 2020. Villas will be completed as phase four, in 2021.

If your deck is scheduled to be stained, Neubauer will notify you ahead of time with a note on your door. Please ensure you remove your personal property from the deck ahead of it being stained, as Neubauer's crew will not move personal property and will instead leave a can of stain near the sliding door on the deck for the Owner to complete their staining themselves. To avoid this, please ensure your deck is clear of personal property in time for staining work to begin!

TREE TRIMMING AND REMOVAL

In October 2019, Gamma Tree Service completed the trimming of nearly 50 trees and removal of nine from the Woodside Trails community. In 2020 additional tree trimming and removal will be completed. One of our largest maintenance items each year is our trees. They are also one of the most enjoyed part of living at Woodside Trails, according to a resident survey conducted in 2018. Our community prides itself on its appearance and safety, and ensuring our trees are properly taken care of is a big part of keeping WST both safe and looking great!

SPORTS COURT UPDATE

You may have noticed that the tennis court is now a sports court! The sports court now includes the necessary marking for Pickleball and also a brand new basketball hoop! Please take advantage of the beautiful spring weather and have some fun utilizing this fantastic amenity!
